OFFICER NOMINATION FORM

The Lord calls certain men, as recorded in the Scriptures, to serve Him and His Church in leadership roles as Elders and Deacons.

The primary qualification for Elders and Deacons is to be "above reproach" (I Timothy 3:2) or "blameless" (Titus 1:6). Being blameless does not indicate a sinless perfection, but being characterized by moral integrity in all areas of life. Specific areas are listed in I Timothy 3:1-13 and Titus 1:5-9.

"It is a trustworthy statement; if any man aspires to the office of overseer, it is a fine work he desires to do. An overseer, then, must be above reproach, the husband of one wife, temperate, prudent, respectable, hospitable, able to teach, not addicted to wine or pugnacious, but gentle, uncontentious, free from the love of money. He must be one who manages his own household well, keeping his children under control with all dignity (but if a man does not know how to manage his own household, how will he take care of the church of God?); and not a new convert, lest he become conceited and fall into the condemnation incurred by the devil. And he must have a good reputation with those outside the church, so that he may not fall into reproach and the snare of the devil. Deacons likewise must be men of dignity, not double-tongued, or addicted to much wine or fond of sordid gain, but holding to the mystery of the faith with a clear conscience. And let these also first be tested; then let them serve as deacons if they are beyond reproach. Women must likewise be dignified, not malicious gossips, but temperate, faithful in all things. Let deacons be husbands of only one wife, and good managers of their children and their own households, For those who have served well as deacons obtain for themselves a high standing and great confidence in the faith that is in Christ Jesus." (I Timothy 3:1-13)

To be elected to the office of Elder or Deacon at Christ Covenant, the following is required:

- Communing member for at least two years by election date (June 2019)
- Nomination by two members (from different families) of the congregation
- Completion of the Leadership Training Class
- Examinations and approval by the Elders to stand for election
- Election by the congregation

I. GENERAL INFORMATION

- A. How long have you known the nominee?
- B. In what capacity have you observed his service?

II. BIBLICAL CHARACTER AND COMMITMENTS: (The Session of Christ Covenant Presbyterian Church has considered the Biblical qualifications for church officers set forth in I Timothy 3 and Titus 1 by delineating the 12 areas in which a nominee should model maturity in order to be nominated and elected to church office.)

I attest that he has been a member of Christ Covenant Church for at least 24 months (I Tim. 3:6,10 and 4:12).

I attest to the basis of his assurance of salvation (I Tim. 3:9; Titus 1:9).

I attest to Christian maturity and minimum age standards (I Tim. 3:6,10).

> Elder: A convert and member of an evangelical church for at least 5 years and normally at least 30 years old at ordination or installation.

> Deacon: A convert and member of an evangelical church for at least 3 years and normally at least 24 years old at ordination or installation.

I attest to involvement in one or more ministries of the church in which he has exhibited both gifted and servant leadership in areas such as small groups, evangelism, compassion, discipleship, teaching or music (I Tim. 3:10; 4:12).

I attest that his character, personal integrity, and spiritual leadership in regard to his family, the church, the world is becoming to a Christian, a church member, and an officer of the church. That he has the support of his wife in pursuit of ordained office. (I Tim. 3:2,7; Titus 1:6).

I attest that he is consistent in his efforts to have a regular devotional life that includes prayer and Bible study as a pattern (I Tim. 4:12, 3:11; Titus 1:8-9).

I attest that he has the time, willingness, schedule, and gifts to perform the duties required of the office, including regular attendance at the stated meetings of the Session or Diaconate, and meetings of Departments to which he may be assigned (I Tim. 3:10,11).

I attest to a consistent pattern of participation in Sunday School, Sunday morning and evening worship services, and the support and concern for other major church-wide services and ministries (I Tim. 4:12, 3:10-11).

I attest to a consistent pattern of willfully and joyfully tithing his first fruits to the church (I Tim. 3:3-5,12; Titus 1:7).

I attest that he is in accord with the direction of the church and that he can serve in harmony with others (I Tim. 3:3,8; Titus 1:7).

I attest that he has a heart of pastoral concern for the congregation and his fellow church officers (I Tim. 3:3-5, 4:12).

I attest that he is not a member of any secret organization (e.g. Masons, Knights of Columbus, etc.).
